- 1. Payments** - An initial Reservation Fee of \$500 is required with the signed contract to hold shooting dates and pre-production video planning. The Reservation Fee is non-refundable. Cheques should be made out to Falls Video.
- 2. Delivery of Finished Product** - The client is welcome to pick-up the finished product(s) in person or they can have it delivered to them once final payment is received.
- 3. Exclusive Rights** - It is understood Falls Video is the exclusive, official videographer retained to produce the product(s) specified on this contract.
- 4. Usage** - Falls Video reserves the right to use the video for demonstration, display, publication or other purposes.
- 5. Postponement/Cancellation** - In the event of a postponement or cancellation of the contract, any extra deposits will be returned, however the Reservation Fee is non-refundable. No refunds will be made after delivery of the product(s).
- 6. Liability** - Falls Video takes the utmost care with respect to the production, postproduction and delivery of the product(s). However, in the event Falls Video fails to comply with the terms of this contract, Falls Video liability is limited to the Reservation Fee and deposits paid by the client.
- 7. Assigns/Substitutions** - In the event of illness or any other reason, Falls Video reserves the right to substitute the videographer(s) assigned to the production.
- 8. Additional Charges** - After the product(s) has been delivered to the Client, there will be a charge for re-editing at the rate of \$100.00 per edit hour; there will be no charge for re-editing less than one edit hour. Re-editing is available to the client for a period of (7) seven days after delivery of the product(s). Unforeseen parking fees and tolls incurred will be charged to the client.
- 9. Warranties** - Falls Video makes no warranties express or implied.
- 10. Production and Editorial Control** - Falls Video is granted full production and editorial control by the client regarding all aspects of the production of this product. If a particular segment is either not recorded, partially recorded, or not part of the edited program, it is at the sole discretion of Falls Video as the exclusive producer of the video recording.
- 11. DVD Compatibility** - Falls Video produces DVDs using the most compatible media for brand name DVD players. Falls Video is not responsible for incompatibility with the DVDs created and the client's player. A sample DVD is available for testing upon request.
